I am happy to inform you that our school project is making steady progress. An important landmark event in the previous financial year was the *Bhoomipoojan* and foundation stone laying ceremony on February 12, 2014. The office bearers of the Trust and most of the other Trustees were present in the function. Some eight member of Round Table Varanasi, our partners in the project, including their present president, past president and regional president, also attended the function. The Chairman of the Trust, Sri Vibhava Bhushan Upadhyay, laid the first brick, followed by other Trustees and members of the Round Table. Residents of the nearby villages were also invited. They gathered in good numbers. We explained our vision and the innovative features of our school project and sought active cooperation of the local residents. Their response was very positive.

After the Bhoomipoojan we started the construction of a two room office cum store unit. The structure for unit has come up to the plinth level. and one of the rooms has been raised up to the roof level.

We have now signed an agreement with the Round Table and they have become our official partners. We will provide the land and they will construct the school building. They are finalizing the construction plans and expect to start work by the end of this month. I take this opportunity to thank them and express our appreciation for their much needed support.

Our fund raising effort is also gaining momentum. In the previous year we received fifty six donations totaling Rs. 16 Lac. The number of our donors has now risen to 143. We are consolidating our funds to acquire more land for expansion. At present we have 0.261 hectare of land. For CBSE affiliation we need 2 acres = 0.81 hectare. That is, 0.549 hectare more land has to be purchased. The cost of this additional land will be nearly Rs.60 Lac. That means we need to raise about Rs.40 lac more. I am sure with your active support we can reach this target in a year or so.

I look forward to your continued support for the project. This could be by way personal donations or by actively seeking support from others, particularly institutional support from the corporate sector
